

# AIFS Abroad Using Financial Aid for Study Abroad

Many students have been able to participate in study abroad programs with the assistance of loans, grants and/or scholarships from their home institutions. Your school may agree to apply aid to your study abroad program. If you plan to use your financial aid award to pay for all or part of your AIFS fees, please read and follow the procedures listed below.

#### **Applying for Financial Aid**

Apply early. It is very important that students who plan to use financial aid to pay their AIFS fees apply as soon as possible. This will enable you to receive notification of your award and, consequently, determine before the final AIFS payment deadline whether you will be financially able to participate in the program.

It is your responsibility to make sure that all documentation is filed both at your home institution and AIFS by the appropriate deadlines. Any balance of fees that will not be covered by aid must be paid in full to AIFS by the final AIFS payment deadline. You will not be permitted to start classes or allowed to reside in AIFS housing until all financial arrangements have been made.

Regardless of how much financial aid you are expecting, the following items must be paid to AIFS by the payment deadline:

- enrollment deposit (due with your application/online enrollment form)
- any \$50.00 optional tour deposits
- \$850.00 program reservation deposit (due by the final payment deadline)
- Transportation Package and mandatory additional U.S. government and airline-imposed departure taxes, fees and fuel surcharges (if a flight is offered, and you are purchasing your flight through AIFS) (due by the final payment deadline)
- payment for optional program components (refer to the Payment Schedule section on the AIFS Program Information Sheet to see what amounts are due by the final payment deadline)
- any remaining balance of your AIFS fees that will not be covered by financial aid (due by the final payment deadline)

### AIFS Financial Aid Form Part 1 (attached)

It is your responsibility to complete this form and return it to the AIFS Customized, Faculty-Led Programs office in Stamford, Connecticut prior to the final payment deadline. This form is an explanation of how your fees will be paid to AIFS and assures AIFS that, in the event that your financial aid funds are not received by AIFS, you will be responsible for program payment. If your AIFS balance is not paid in full by the last disbursement date of your loan/scholarship, you will be administratively withdrawn from the program.

### AIFS Financial Aid Form Part 2 (attached)

It is your responsibility to arrange to have documentation sent from the financial aid office or lending institution to AIFS stating the amount of your award/loan and the date that it will be disbursed. Part 2 of the "AIFS Financial Aid Form" must be completed by the financial aid officer at your institution or lending agency and returned to the AIFS Customized, Faculty-Led Programs office in Stamford, Connecticut prior to the final payment deadline. We ask that the officer completing the form list only those awards that you will use for payment toward the AIFS fee, subtracting any processing fees, since those amounts cannot be used toward the AIFS fees. Any AIFS balance that is not covered by financial aid must be paid on or before the final payment deadline.

If the financial aid office cannot complete Part 2 due to federal regulations, they should indicate so on Part 2 of this form. In that case, you would be responsible for providing AIFS with documentation of your awards.

Note: Like the *Financial Aid Forms*, this form assures AIFS that, in the event your financial aid funds are not received, you will assume full responsibility for program payment. **Again**, **if your AIFS balance is not paid in FULL after the last disbursement date of your loan**, you will be administratively withdrawn from the program. Unpaid balances will be reported to a credit-reporting agency.

#### **REFUND POLICY**

If you are notified by your institution or lending agency that you have not been awarded financial aid (in full or in part) and are, therefore, unable to participate in the program, you will receive a refund of all fees paid to AIFS less \$450 plus any non-refundable deposits paid by you or by AIFS on your behalf, **provided you notify AIFS in writing by the program's final payment deadline.** Notification must include verification from the financial aid office or lending agency that the amount requested was not granted in full or in part, and that the amount awarded was not sufficient to cover the AIFS program fees.

Failure to request a refund from AIFS by the final payment deadline will result in full forfeiture of all fees paid to AIFS.

Please note that if a financial aid award is canceled or reduced by your institution or lending agency after you have embarked on the AIFS program, you are **immediately responsible for full payment of all fees**. Failure to make payment will result in your administrative withdrawal from the program.

Financial aid will be used first by your home institution to cover any outstanding balances with your institution. Any remaining balance may be used to pay your AIFS fees. Take this into account when calculating the amount of aid you will apply to your AIFS balance.

Additionally, if you withdraw from the program after departure and while awaiting disbursement of financial aid funds, those funds are still due to AIFS upon disbursement.
